### PROCEDURE:

Auditory Brainstem Evoked Potential was recorded using monaural stimulation of both the ear. Filter setting of 100Hz to 3KHZ was used to elicit the response. Both ears were stimulated at maximum intensity level of 90 dBnHL & 70 dBnHL. Reproducibility of the wave from was seen.

### FINDINGS:

Bilateral ear: Peak V present at 90 dBnHL and absent at 70dBnHL.

### CONCLUSION:

The BERA study is abnormal and indicates pathology in Cochlea and Auditory Pathway.

Bilateral ear: Moderately - severe hearing loss.

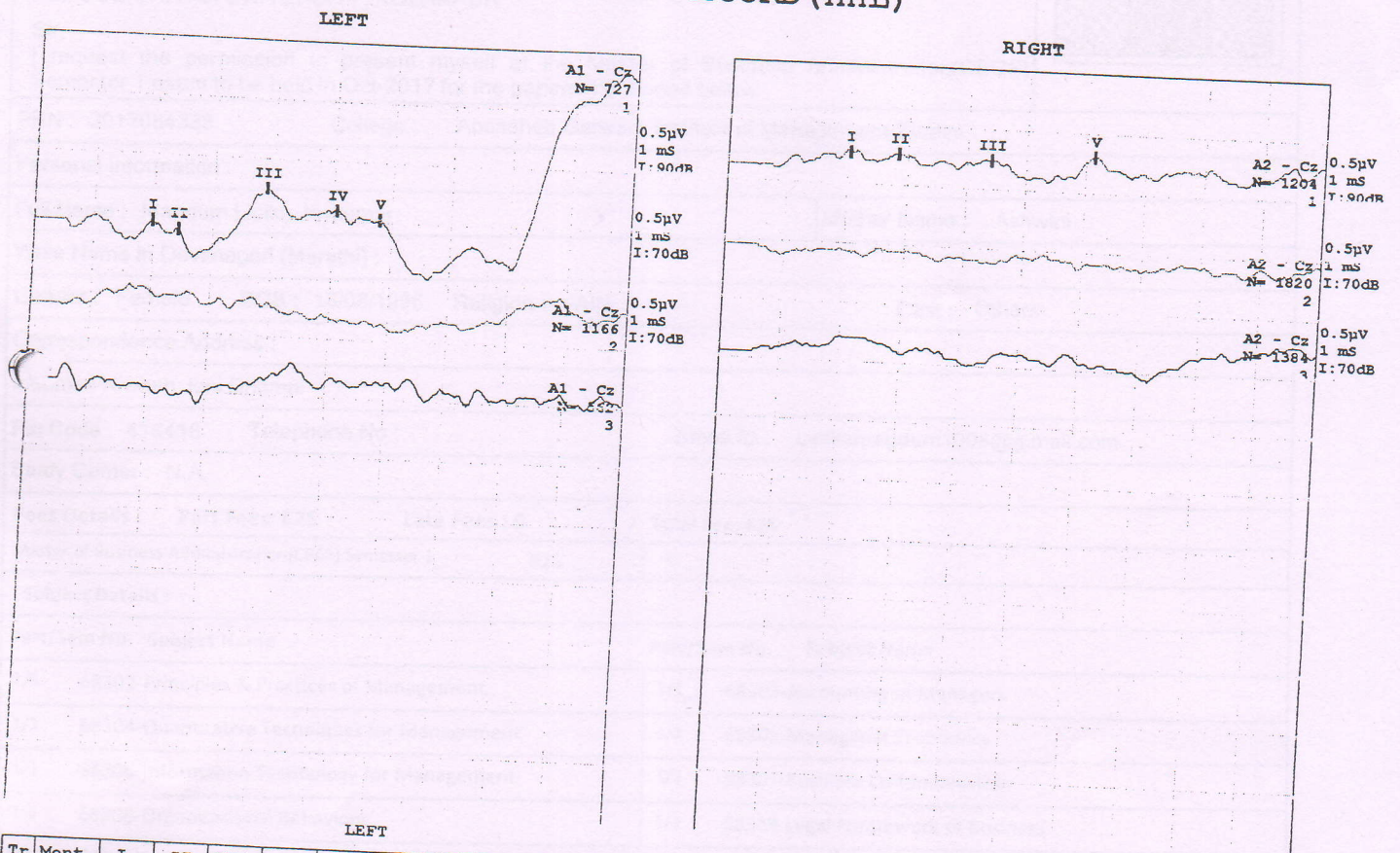

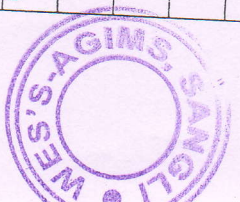
